Overall Purpose of the Role

To support the operation of the Peatland Code, an innovative funding mechanism for peatland restoration. To support activity, including project registration on the UK Land Carbon Registry, promotion and training of the Peatland Code for those developing projects and responding to approached from buyers, project developers and other interested parties. To support integration with the NatureScot Peatland ACTION programme for any Peatland Code applications requesting such public funds as part of their financing strategy.

- 1. Provide technical input to the team in relation to the Peatland Code standard and its operation, inclusive of the appropriate inclusion of NatureScot Peatland ACTION applications for funding for capital works for individual projects.
- 2. Administrate registration of new projects on the UK Land Carbon Registry.
- 3. Respond to general inquiries regarding the Peatland Code including those from partners, landowners, businesses and peatland practitioners.
- 4. Enhance and maintain the content for the Peatland Code website.
- 5. Support the provision of external briefings on the Peatland Code for potential investors, stakeholders and restoration projects including Peatland ACTION Officers.
- 6. Support the promotion of the Peatland Code through engaging with project developers, including public and private landowners and preparing and giving presentations to showcase the Peatland Code.

- Provide training and guidance on the operation and rules of the Peatland Code for project developers and investors and support new peatland projects in drawing up proposals.
- 8. Support the Peatland Code Coordinator in maintaining an overview of carbon and other ecosystem service markets and supporting policy framework in UK and internationally to get an understanding of new developments and ensure the Code is well aligned to future market mechanisms.
- 9. Support the wider work of the IUCN UK Peatland Programme in advocacy and briefing particularly relating to natural capital investment, climate change policy and the economic case for peatland restoration.

Some out of normal hours working and travel across the UK will be required.
