Overall Purpose of the Role

To work with the Reserve Manager to provide high quality conservation management on 8 wildlife reserves. The West Central region covers South Lanarkshire, North Lanarkshire, Glasgow, Stirlingshire, Argyll and Kintyre The eight reserves within the region contain a range of habitats including Atlantic hazel wood/Celtic rainforest upland native woodland, wet woodland, raised bog, marsh, swamp and freshwater loch.

Main Objectives

- Work with the Reserve Manager to manage a diverse portfolio of 8 wildlife reserves.
- Plan, implement and oversee practical reserve conservation and maintenance work in accordance with management plans/statements. Manage &/or develop volunteer teams to assist with this work as appropriate.
- Contribute to the development of management plans/statements for these reserves and report on activity on them.
- Assist with the preparation of contract documentation for reserve maintenance work and supervise contractors.
- Carry out a programme of wildlife and habitat monitoring across selected reserves.
- Assist with the development of new conservation projects on selected reserves.
- Assist with compliance with health and safety of all operations, including safe working practices, premises safety, and reserve safety.
- Promote nature conservation and the work of Scottish Wildlife Trust through talks, walks and events as well
 as day-to-day engagement with members of the public.
- Deputise for the Reserve Manager as required.
