# **Overall Purpose of the Role**

To support and assist the Perthshire Ranger in providing osprey nest and other species protection at the Loch of the Lowes Wildlife Reserve.

#### **Main Objectives**

You will be expected to;

- · Monitor and record breeding ospreys' behaviour
- Provide protection for the resident ospreys, their nest, eggs, chicks and other species during the critical part of the breeding season.
- Engage with members of the public, both in the hides and on regular patrols around the reserve.
- Intervene and take appropriate action in incidents of disturbance
- Work closely with Visitor Centre staff and volunteers
- Monitor additional webcams for beaver activity and other wildlife footage

- Produce an end of season summary report
  - Monitor the nest from the hides, security cameras and webcam to watch for potential
- disturbance events.
- Patrol reserve on a regular basis.
- In the event of disturbance to ospreys and other wildlife, WPOs may be required to talk to
- members of the public to discuss their actions and raise awareness regarding the Scottish
- Outdoor Access Code and legislation pertaining to protected species.
- Liaise with Wildlife Crime officer and local police as appropriate.
- Liaise, support and work with local volunteers to ensure protection is maintained.
- Report regularly to line manager and other staff during shift change-overs.
- Review osprey webcams for incidents and interesting footage.
- Provide shift summary to members of the Visitor Centre and Communications Team.
- Upload observed osprey behaviour into data spreadsheet.
- Co-create an end of season summary report.
